HOW TO RECOMMEND/ APPROVE A LPCO



Intended Audience:
This Manual is intended for Government Agency users.

1. INTRODUCTION

All requested LPCO documents are subject for review by the concerned agency. To process an LPCO document, follow the steps below:

2. STEPS

1. Login to the LPCO application.
2. Use the search filter or just click on the Search button to view list of LPCOs.



3. Open a document you want to review by clicking on the pencil icon.
